# Regulations for Large Study Trips of Stichting Marie Curie Reizen

This translation was made to clarify the content of the regulations to those interested in the Stichting Marie Curie Reizen study trip that do not speak Dutch. It was attempted to give as full a translation as possible, but in all cases only the original, Dutch regulations are binding.

#### 1. Definitions

- a) With Marie Curie we mean Studievereniging Marie Curie voor Natuur- en Sterrenkunde in Nijmegen (Study Association Marie Curie for Physics and Astronomy in Nijmegen), in the foundation's statutes they are called Studievereniging voor Informatica en Natuurkunde in Nijmegen Marie Curie (Study Association for Physics in Nijmegen Marie Curie).
- b) With members of Marie Curie we mean the members, beneficiaries or honorary members of Marie Curie.
- c) With study trip we mean a certain study trip or exchange, as mentioned in the foundation's by-laws (article 3, paragraph 1 of the foundation's by-laws).
- d) With large study trip we mean a study trip with a duration of eleven or more days
- e) With committee we mean the committee of the foundation tasked with organising the specific study trip (article 11 of the foundation's by-laws).
- f) A person is considered to be a person who is eligible for study trip participation for a specific study trip if they is a student or exam taking student at the field Physics and Astronomy at the Radboud University (RU) at the time of both the draw and the study trip. This student or exam taking student will further on be called a Physics and Astronomy student.
- g) A person is considered to be drawn out when he or she has participated to the draw procedure of the previous large study trip but was not offered participation.
- h) All parts of the large study trip include/consist of the study trip itself and assignments given by the committee and the scientific supervisor, up to and including the approval and settlement of the accounts/financial administration of the specific study trip.

- i) With a fine we mean a financial levy imposed by the committee to a participant, originating from failing to follow an article of the regulations by a participant. The articles for which this is possible, as well as the amount of the fine, will be specified in these regulations. The fine will benefit the Stichting Marie Curie Reizen.
- j) With a personal levy we mean a financial levy imposed by the committee to a participant, originating from missing study trip incomes due to individual reasons. The collected personal levies will at all times only benefit the specific study trip for which the participant participates. Members of the committee are protected from personal levies unless the foundation board decides otherwise.

#### 2. Target audience

The large study trip is targeted to persons who are eligible for study trip participation. The foundation board can decide to add other persons to the target audience.

### 3. Categorization

The following categories exist:

- a) Members of the committee and potential scientific employees of the RU Nijmegen, to be appointed by the committee.
- b) Persons within the target audience that have obtained at least 99 EC from the list in article 10 and/or are enrolled in a master's degree Physics and Astronomy, have never participated in a large study trip of Stichting Marie Curie Reizen or another similar study trip acknowledged by the foundation except when they were categorized in category a) and were drawn out for the previous large study trip of Stichting Marie Curie Reizen when they were categorized in category b), c), d) or e). Additionally, these persons are in possession of a driver's license similar to the Dutch license "Rijbewijs B and are willing to drive a passenger car during the study trip. From this group, there will be a maximum of two participants drawn so there are enough drivers on the trip. The other persons in this group will be drawn as persons in category d).
- c) Persons within the target audience that have obtained at least 99 EC from the list in article 10 and/or are enrolled in a master's degree Physics and Astronomy, have never participated in a large study trip of Stichting Marie Curie Reizen or another similar study trip acknowledged by the foundation except when they were categorized in category a). Additionally these persons are in possession of a driver's license similar to the Dutch license "Rijbewijs B" and are willing to drive a passenger car during the study trip. From this

group, there will be a maximum of two participants drawn so there are enough drivers on the trip. The other persons in this group will be drawn as persons in category e).

- d) Persons within the target audience that have obtained at least 99 EC from the list in article 10 and/or are enrolled in a master's degree Physics and Astronomy, have never participated in a large study trip of Stichting Marie Curie Reizen or another similar study trip acknowledged by the foundation except when they were categorized in category a) and were drawn out for the previous study trip of Stichting Marie Curie Reizen when they were categorized in category b), c), d) or e).
- e) Persons within the target audience that have obtained at least 99 EC from the list in article 10 and/or are enrolled in a master's degree Physics and Astronomy, have never participated in a large study trip of Stichting Marie Curie Reizen or another similar study trip acknowledged by the foundation except when they were categorized in category a) and have never been drawn out for a previous study trip of Stichting Marie Curie Reizen when they were categorized in category c) or e).
- f) Persons within the target audience that have obtained at least 99 EC from the list in article 10 and/or are enrolled in a master's degree Physics and Astronomy and have participated exactly once in a large study trip of Stichting Marie Curie Reizen or another similar study trip acknowledged by the foundation except when they were categorized in category a).
- g) Persons within the target audience that have obtained at least 99 EC from the list in article 10 and/or are enrolled in a master's degree Physics and Astronomy and have participated at least twice to a large study trip of Stichting Marie Curie Reizen or another similar study trip acknowledged by the foundation except when they were categorized in category a).
- h) Persons within the target audience who have obtained less than 99 EC from the list in article 10 and are not enrolled in a master's degree Physics and Astronomy.
- i) Persons who do not belong to the target audience.

The foundation board can always decide to assign a categorization to persons that is other than prescribed above.

#### 4. Draw procedure

The draw procedure includes determining the order of priority of the people who registered for the study trip in question in the following way:

- a) The order of the people in different categories, as indicated under 3), is as follows: category a) has the highest priority, the priority decreases in alphabetical order.
- b) The moment of the draw has to be announced either a week in advance on paper, or at the moment of registration, to all of those who have registered for the study trip, as well as to the foundation board. Everybody has the right to be present at the draw.
- c) The list of participants is to be composed out of persons who are eligible for participation in order of decreasing priority, up until the maximum amount of participants decided upon by the committee. The remaining persons will be put upon a list of reserves in the same order. This composition has the following exceptions:
  - i. The committee retains the right to deviate of the order of priority, provided that the foundation board has approved this and the deviation, and its argumentation, is announced prior to the draw to all people who show interest for the study trip as well as those who have registered for the draw.
  - ii. The committee retains the right to exclude persons from the study trip, provided that the foundation board has approved this and the deviation, and its argumentation, is announced prior to the draw to all people who show interest for the study trip as well as those who have registered for the draw.

## 5. Organizational committees

- a) Committee members will not receive a reward for their work at the expense of the study trip. They do however have the right to be compensated for the costs made while performing their functions. This includes one dinner of the committee together with the scientific supervisor.
- b) The committee has the right to exclude a participant from further participation, if this participant behaves in such a way that the committee feels as though the success of the study trip becomes endangered. In case this happens outside the period of the study trip, the foundation board needs to authorize. The committee has the right to collect any additional costs incurred as a result from the participant in the form of a personal levy.
- c) The foundation board can only approve the final financial settlement of the committee after it has appointed two persons to, both not members of the concerned committee, to check the accounts of the treasurer of the committee. The final financial settlement can only be approved after this check has been done.

#### 6. Obligations of the committee

- a) The organizing committee is obligated to notify anybody who registers for the study trip about the existence of these regulations and any conditions for which can be deviated from these regulations, and should provide these to the registered persons.
- b) The committee is obligated to announce the following amounts ahead of the opening of the registrations to all interested persons: the minimum contribution to the study trip, the expected contribution to the study trip and the maximum contribution to the study trip.
- c) In collaboration with the scientific supervisor, the committee has to determine dates before which either a by the committee specified part or the entire contribution has to be paid by the participant. The participant have to be informed about this at least two weeks before these dates.
- d) The committee is obligated to provide the budget and the final financial settlement of the committee, after these have been approved by the foundation board, to any participant who asks for it.
- e) The committee is obligated to announce the requirements for any potential assignments as well as any travel reports to all participants. This includes, among other things, the final deadline and a distribution of the different components of a report by the participants. This announcement has to be made to all participants at least three weeks before the first deadline.
- f) The committee has to determine dates before which the participants have to be vaccinated against or have proof of recovery from diseases, have a passport, a possible visa, a medicine permit and travel insurance. The participant have to be informed about this at least six weeks before these dates.

#### 7. Obligations of registered people

- a) Everyone that has registered agrees with and is bound to the regulations.
- b) Everyone that has registered must be a member of Marie Curie during all of the activities of the study trip in which they participate. Renunciation leads to this person paying the fees that the study trip miss out on. This fine will be imposed as a personal levy on the participant.
- c) Everyone that has registered must be a member of the Dutch Physical Society (NNV) until at least one month upon arrival back in the Netherlands from the study trip they participated on. Renunciation leads to this person paying the fees that the study trip miss out on. This fine will be imposed as a personal levy on the participant.

- d) Everyone that participates or has participated in a study trip is obligated to pay the contribution fee that the organising committee has determined and is specified under 6(b) and 6(c) besides potential personal levies and/or imposed fines. Not paying before the dates that are determined by the organising committee may result in being removed from the list of participants or the list of reserves. Here article 8 will be considered concerning the costs that are made. If the contribution fee has not been paid a month before departure of the study trip it will be considered as a cancellation.
- e) Everyone that participates in the study trip is obligated to perform a potential assignment, as well as writing a contribution to a potential travel report if the committee considers this necessary. The committee is allowed to apply small modifications to the contributions written by the participants. Any written contribution will remain available for use by any subsequent committee. These are mandatory components and the definitions are specified under 6(e).
- f) A fine may be imposed, specified under 7(d), on anyone that does not complete in time or hand in an inadequate assignment, according to the judgement of the committee, specified under 7(e). The imposed fines are €5 if the final deadline is not achieved and an extra €2 for every day on which the contributions are not handed in either. Plagiarism will be considered as an inadequate contribution.
- g) Everyone that participates in the study trip must be vaccinated against of recovered from the diseases specified under 6(f). If participates can not prove that they are vaccinated of recovered before the data that are imposed by the committee under 6(f), the committee is able to remove this participant from the list of participants or the list of reserves. Here article 8 will be considered concerning the costs that are made.
- h) Everyone that participates in the study trip is aware that a passport and a possible visa is required to enter the country.
- i) Everyone that participates in the study trip is obligated to have travel insurance, and a possible medicine permit for any medicine they want to bring on the study trip.

### 8. Cancellation

- a) Everyone has the right to cancel their registration without costs as long as the person has not yet confirmed their agreement with these regulations by signing it.
- b) If the situation arises that a participant is removed from the list of participants, the list of reserves will be taken into account. People from this list are

asked in the order that is specified under 4(c) to replace the removed participant. Refusing leads to being removed from the list of reserves but does not lead to costs on behalf of the person that is asked.

c) Up until three months before the departure of the study trip, a participant can cancel their trip, while only paying the already made costs for that particular person. Cancellation within three months of the departure of the study trip does not lead to remission of (a part of) the contribution fee, unless the committee decides differently.

## 9. Procedure of appeal

If anyone does not agree with a decision made by the committee, concerning their category division, the draw, their participation, or the fees they are being obligated to pay, they can appeal to the foundation board. They have the right to be present during a meeting of the foundation board and elucidate their appeal in word.

## 10. Courses that are of influence on the category division

The amount of EC stated in the table below can be exposed to changes. The amount of EC are stated in the most recent study guide for the bachelor of physics and astronomy and is leading for the category division.

If two courses replace one course, they can also be accounted for as two 3 EC courses.

The foundation board can always decide to approve non-stated courses, e.g. courses that are taken abroad.

## 11. Additional conditions

- a) The individual subsidies acquired from the FNWI are met with the following rule: The subsidies solely benefit the study trip.
- b) The participants that are not qualified for the subsidies mentioned above will be obligated to pay the fees that are missed out on. This does not apply to members of the committee, nor the participants that once were in an organising committee and have not made use of this regulation before.

# 12. Final provision

If situations arise where these regulations are not applicable, the decision lies with the foundation board.
